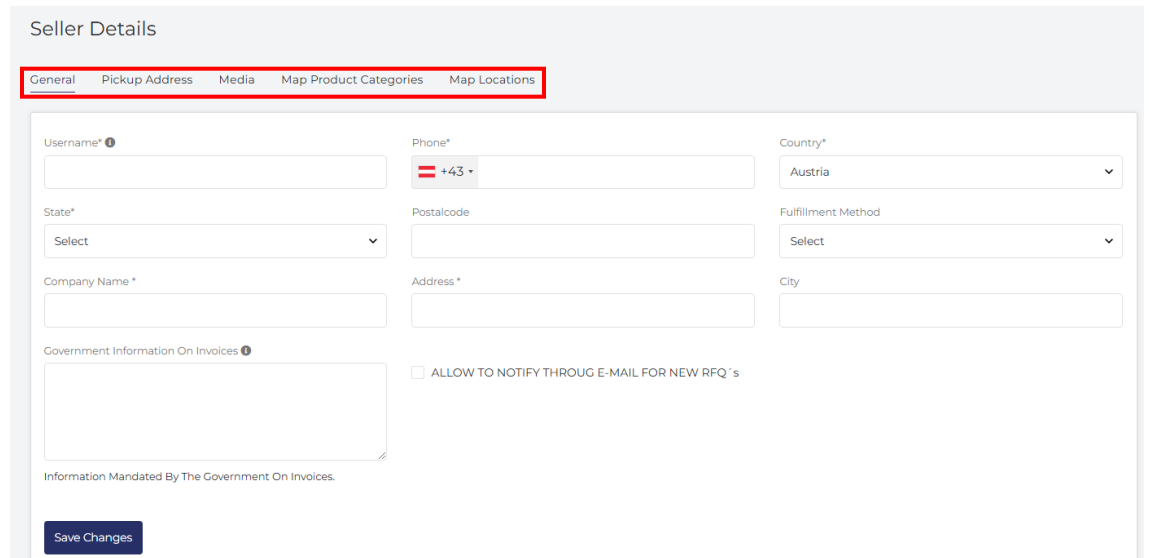


5. Now you are able to login.
